Welcome to sharedinvestigator.com (the "**Website**"). This Website hosts the Shared Investigator Platform ("Platform") and the Investigator Registry ("**Registry**"), initiatives developed by several of the members of TransCelerate BioPharma Inc. ("**TransCelerate**") in response to the need for greater collaboration and efficiency in conducting clinical trials.

TransCelerate is an association of more than twenty leading global clinical trial sponsors. It is a non-profit organization with a mission to collaborate across the biopharmaceutical research and development community to identify, prioritize, design and facilitate the implementation of solutions to drive efficient, effective and high-quality delivery of new medicines, improving the health of people around the world. This Website is operated and hosted by Cognizant Technology Solutions U.S. Corporation ("**Cognizant**"), a company incorporated in the State of New Jersey with its registered office in 500 Frank W. Burr Boulevard, Teaneck, NJ 07666, United States of America, and its third party licensors and partners.

Several TransCelerate member companies have been working with Cognizant to develop this Platform, to facilitate investigative site collaboration with participating clinical research sponsors. The Platform aims to facilitate the investigative site's interaction with multiple participating clinical trial sponsors ("**Sponsors**"), and enables study planning, study start-up and study conduct via a single point of access; additionally it delivers harmonized content and services to investigator sites. ARTICLE I

The Platform incorporates the Registry, an initiative developed by several of the members of TransCelerate in collaboration with DrugDev Inc., a company incorporated in the State of Pennsylvania with is registered office at 1170 Devon Park Drive, Suite 300, Wayne, PA 19087, USA (“**DrugDev**”). The Registry contains investigator contact information, site profile information, and other data related to investigators and sites. The Registry can be accessed by Sponsors, sites, and investigators through the Platform. The Registry is hosted and operated by DrugDev . ARTICLE II

These Terms of Use set out the terms of your use of the Website, including the Platform and the Registry. These Terms of Use govern your relationship with TransCelerate, Cognizant, the Sponsors and DrugDev (“**we**” or “**us**”), subject to the section below entitled ‘Platform Participation by Investigators Working With Sponsors’.
